## <u>Ref.: Relevant Fact – Acceptance of two resignations – Appointment of alternate Director as Director and appointment of two new alternate Directors – New composition of the Board.</u>

Dear Sirs,

We are pleased to contact you on behalf of the company TGLT SA ("TGLT" or the "Company") in order to inform you that on the meeting held on April 8, 2014, from 3pm to 5:30pm, the Board of the Company accepted the resignations submitted by Ezequiel Segal to his position as Director and by Cynthia Lorena Vatrano Natale to her position as alternate director of the Company.

Furthermore, the Auditing Commission of the Company, during the meeting held on April 8, 2014 from 7pm to 7:30, under the power conferred by Section 258, second paragraph, of Law 19550 and its amendments (Argentine Companies' Law), has decided to appoint the replacement directors who shall hold office until the next Shareholders Meeting takes place, namely: (i) to replace Ezequiel Segal, his alternate director, Rodrigo Javier Lores Arnaiz, an Argentine citizen, Certified Accountant and holder of Identity Card N° 22.157.386, is appointed as Director of the Company; (ii) to replace the position of alternate director which Rodrigo Javier Lores Arnaiz left vacant as set forth in (i) above, Luciano Alexis Loprete, Argentine citizen, lawyer and holder of Identity Card N° 28.752.377, is appointed as alternate director of the Company; and (iii) in order to replace Cynthia Lorena Vatrano Natale, Alejandro Belio, Argentine citizen, architect and holder of Identity Card N° 12.089.427 is appointed alternate director of the Company.

The new directors appointed on this date meet the requisites to be "executive" officers in accordance with the standards set forth by the National Securities Commission (the "CNV", as per Spanish acronym) and, on even date, have accepted their respective appointments.
